
## Data Update

Have you ever wondered how the data you enter supports Dane County's EMS system? The data you submit provides valuable information to support your agency's operations, training, and QA/QI processes. In addition, data drives county-wide initiatives such as cardiac arrest summaries, opioid-related analyses, and rapid COVID-19 surveillance. This information also provides valuable information to the receiving facility, adding context and a continuity of patient care reporting to the events leading up to hospital arrival.

As of July 15<sup>th</sup>, EMS agencies in and around Dane County have responded to 22,616 calls in 2020. This puts the year-to-date 2020 call volume across Dane County exactly 10 calls above this time last year. While the beginning of this year started with increased call volume levels, Dane County saw a dramatic decrease in call volume from late March to early June, which has since returned to early 2020 levels. Compared to 2018 and 2019, Dane County EMS agencies have seen an increased share of calls for alcohol & substance abuse, behavioral & mental health emergencies, cardiac arrest, respiratory, and infectious disease emergencies in 2020. The most common dispatch-reported complaints (problems reported in your CAD info) of 2020 are as follows. Until 2020, falls had been the most commonly reported dispatch complaint.

- 1) Sick Person 21%
- 2) Falls 20%
- 3) Unconscious/Fainting 14%
- 4) Breathing Problem 14%
- 5) Chest Pain (non-traumatic) 10%

## Hot Topic

## If I am licensed as a paramedic but running as an EMT or AEMT, can I interpret EKGS?

In the state of Wisconsin, you can only practice to the level you are credentialed at for the service you are working for, even if you are licensed at a higher level. For example, if you have a paramedic license but are working at a service that operates at the AEMT level, you are credentialed as an AEMT at that service and thus must follow scope of practice of an AEMT. Obtaining an EKG is within the scope of EMT and AEMT, but interpretation of EKG is only in the paramedic scope of practice. EMTs and AEMTs can utilize the computer readings to support decision making and/or send to a receiving facility for online medical control, if a provider is concerned or has questions about an EKG for support.
